PARENTAL ASSUMPTION OF RISK, WAIVER, AND RELEASE FROM LIABILITY

In consideration for the privilege of allowing _____ (child's Name) to participate in the 2021 National Youth Football Championships, the use of the property, facilities and/or services of the National Youth Football Championships / Sports Network International Inc. or any affiliated organization participating, sponsoring, or hosting the events, including travel related thereto, the undersigned agrees as follows:

- RISK FACTORS:** The undersigned understands and acknowledges that participation in The National Youth Football Championships involves a contact sport which involves risks such as, but not limited to, the following which might result from the use of equipment or facilities, from the activity itself, from the acts of others, or from the delay or omission of emergency medical care. **RISK OF PROPERTY DAMAGE, BODILY INJURY, AND POSSIBLE DEATH.**
- ASSUMPTION OF RISK.** The undersigned **ASSUMES ALL RISKS THAT ARISE OUT OF THE ACTIVITY ITSELF, THE USE OF THE EQUIPMENT OR FACILITIES, THE ACT OF OTHERS, OR THE UNAVAILABILITY OF EMERGENCY CARE**, including but not limited to, those **RISK FACTORS** described in section 1 above.
- ACKNOWLEDGMENT OF POLICIES AND PROCEDURES.** The undersigned acknowledges reading and knowing all of the policies and procedures relating to the activities, facilities, and/or equipment and understands that the safe and proper participation in the activity, use of equipment or facilities is dependent upon carefully following such policies and procedures.
- PREREQUISITE SKILLS AND TRAINING.** The undersigned acknowledges that above named child has the requisite skills, qualifications, physical abilities, and training necessary to participate in the activity itself or engage in proper and safe use of the equipment. The undersigned agrees that if he or she has any questions as to what skills, qualifications or training is necessary for their child to properly participate in the activity use the equipment, or facility, then they shall direct such questions to the appropriate staff member on site, Coach, or trip manager.
- RELEASE.** The undersigned **RELEASES** The National Youth Football Championships / Sports Network International, Inc. or any affiliated organizations, the officers, employees and agents of each and agrees **NOT TO SUE** them on account of or in conjunction with any claims, causes of action, injuries, damage, cost of expenses arising out of the activity, including those based on death, bodily injury or property damage whether or not caused by the acts, omissions or other fault of the parties being released.
- WAIVER.** The undersigned waives the protection afforded by any statute or law in any jurisdiction including Florida and Nevada whose purpose, substance, and/or effect is to provide that a general release shall not extend to claims, material or otherwise which the person giving the release does not know of or suspect at the time of executing the release. This means, in part, that the undersigned is releasing unknown future claims.
- INDEMNIFY AND DEFEND.** The undersigned agrees to **INDEMNIFY AND DEFEND** The National Youth Football Championships / Sports Network International, or any affiliated organizations, the officers, employees and agents of each (hereinafter jointly referred to as "indemnitee") of each against, and hold them harmless from any or all claims, causes of action, damage judgments, costs or expenses, including attorney fees which in any way arise from the activity or this agreement which include but are not limited to damages to or destruction of any property of the indemnitee, of any others, injury or death of the undersigned or anyone else or any liability arising from the act or negligent act of the indemnitee, the undersigned or anyone else.
- PAY.** The undersigned agrees to pay for any or all damages to any property or indemnitee caused by the undersigned' child either negligently, willfully, or otherwise.
- REPRESENTATIVES.** The undersigned enters into this agreement for their child on his / her behalf, or child over which they have legal guardianship, himself / herself, his/her heirs, assigns and legal representatives.
- EMERGENCY TREATMENT CONSENT.** The undersigned, on behalf of the above named child, hereby consents to medical treatment in a medical emergency where the undersigned is unable to consent to such treatment.
- INSURANCE.** The undersigned understands that The National Youth Football Championships / Sports Network International, Inc. does not carry participant insurance. The undersigned is encouraged to have their child undergo a physical examination and to purchase health insurance prior to any and all participation.
- ACKNOWLEDGMENT.** The undersigned has read and understands this agreement and realizes it relates to surrendering valuable legal rights and does so freely and voluntarily.
